There was one concern around the exit lanes being considerably narrower than the entrance lane, impacting on simultaneous wide vehicle passing.

There was also discussion on the positioning of the crossing point, but it was noted that it was on the desire line, positioned at the maximum width of the road & would act as a barrier to vehicles both entering and exiting Vincés Road. It was also noted that consideration should be given to signage of this industrial site & that this application is subject to a Compulsory Purchase Order.
